Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding for the fiscal year (FY) 2022 Alaska Native Youth Training and Technical Assistance Program. This program furthers the DOJ's mission by providing comprehensive and culturally relevant training and technical assistance to support Alaska Native villages and communities in their efforts to create, expand, and/or sustain programs, services, and supports for youth.

This solicitation incorporates the OJP Grant Application Resource Guide by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community. OJJDP seeks a training and technical assistance provider to establish a regional network of partnerships to develop and support strategies that will support Alaska Native youth's cultural needs. The successful training and technical assistance provider will be required to engage in strategic planning that includes building sustainable capacity within Alaska Native villages and communities to address challenges of Alaska Native youths along the juvenile justice continuum, ranging from prevention to intervention and treatment.

Statutory Authority

Any awards under this solicitation would be made under statutory authority provided by a full-year appropriations act for FY 2022. As of the writing of this solicitation, the Department of Justice is operating under a short-term "Continuing Resolution;" no full-year appropriation for the Department has been enacted for FY 2022.

Specific Information

Alaska is home to 229 of the 573 federally recognized tribes in the United States. Alaska Native youth face disproportionately high rates of juvenile delinquency, incarceration, substance use, suicide, and expulsion or dropout from school, among other challenges, and have very limited access to prevention and intervention services. To build capacity for Alaska Native youth, OJJDP will fund an eligible entity to provide training and technical assistance to increase access to prevention and intervention programs and services.

Goals, Objectives, Deliverables, and Timeline

Goals

The goal of this project is to provide comprehensive and culturally relevant training and technical assistance to support Alaska Native villages and communities in their efforts to create, expand, and/or sustain programs, services, and supports for youth.

Objectives

The objectives of the project are:

- To provide tools and practical techniques for working across disciplines to facilitate information sharing, communication, and coordination of balanced approaches and data-driven strategies to address Alaska Native youth needs and promote an increase in protective factors to help prevent delinquency.
- To develop and provide culturally competent, community-driven, and data-driven technical assistance to assist villages and communities in preventing and addressing issues related to delinquency.
- To facilitate peer-to-peer consultation and networking between villages and communities to promote problem solving and innovation for Alaska Native youth through the exchange of information and ideas.

Deliverables

The successful applicant should demonstrate the ability to provide or subcontract training and technical assistance for tribal youth-specific programming, including efforts to create, expand, or strengthen tribally driven approaches along the juvenile justice continuum that can range from prevention to intervention and treatment. The successful applicant should also be able to deliver training and technical assistance focused on the following areas: strategic planning and program design, improvement or establishment of data collection systems, partnership development, and sustainability planning.

In addition, the successful applicant should demonstrate their knowledge and experience in: identifying experts to build local capacity for the development and implementation of local strategic plans that use multidisciplinary partnerships, balanced approaches, and data-driven strategies; providing logistics to support training and technical assistance activities; developing and disseminating training materials; and conducting evaluations of training.

Equity and Inclusion

Applicants must include in their application, a plan that describes how the applicant will ensure equitable access to services for all justice-involved children, youth and/or families eligible for the program.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the results of the completed work, as discussed in the "Application and Submission Information" section.

OJJDP Training and Technical Assistance Awardee Standards

Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project, including the purpose of the project, primary activities, expected outcomes, the service area, intended beneficiaries and subrecipients (if known), will be completed in the JustGrants web-based form. This abstract should be written in the third person and will be made publicly available on the OJP website if the project is awarded.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 pages. Pages should

be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The proposal narrative should address the following selection criteria: (1) description of the issue, (2) project design and implementation, (3) capabilities and competencies, and (4) plan for collecting the data required for this solicitation's performance measures. The applicant should clearly delineate the connections between and among each of these sections. For example, the applicant should derive the goals and objectives directly from the problems to be addressed. Similarly, the project design section should clearly explain how the program's structure and activities will accomplish the goals and objectives identified in the previous section.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address. The applicant should use data to provide evidence that the problem exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe the target population and any previous or current attempts to address the problem. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. OJJDP encourages applicants to select evidence-based practices for their programs. This section should also include details regarding any leveraged resources (cash or in-kind) from local sources to support the project and discuss plans for sustainability beyond the grant period.

<u>Timeline.</u> Applicants should submit a realistic timeline or milestone chart that indicates major tasks associated with the goals and objectives of the project, assigns responsibility for each, and plots completion of each task by month or quarter for the duration of the award, using "Year 1," "Month 1," "Quarter 1," etc., not calendar dates (see "Sample Project Timelines" here). Applicants should submit the timeline as a separate attachment, as stipulated in Additional Application Components. On receipt of an award, the recipient may revise the timeline, based on training and technical assistance that OJJDP will provide.

c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the impact of the project. Describe the process that will be used to accurately report data.

Applications that meet the basic minimum requirements will be evaluated by peer reviewers. Applications will be evaluated on how the proposed project/program addresses the following criteria:

- 1. Description of the Issue (5%)- evaluate the applicant's understanding of the program/issue to be addressed.
- 2. Project Design and Implementation (40%) evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
- 3. Capabilities and Competencies (35%) evaluate the administrative and technical capacity to successfully accomplish the goals and objectives.
- 4. Plan for Collecting the Data Required for This Solicitation's Performance Measures (10%) evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
- 5. Budget (10%) evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

b. Other Review Criteria/Factors

Other important considerations for OJJDP include geographic diversity, strategic priorities, available funding, past performance, and the extent to which the Budget Worksheet and Budget Narrative (web-based form) accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements, will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant.
