#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding to develop coordinated and comprehensive community-based approaches to help children, youth, and their families who are exposed to violence build resilience and prevent future violence and delinquency. This program furthers the DOJ's mission by strengthening or improving public safety; reducing violent crime and increasing community trust; and ensuring rights, access to services, and equity for all victims of crime.

# **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

OJJDP's guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will <a href="Irreat Children as Children">Irreat Children as Children</a>; Serve Children at Home, With Their Families, in their Communities; and Open Up Opportunities for System-Involved Youth. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to provide funding to communities to develop coordinated and comprehensive community-based approaches to help children and their families who are exposed to violence build resilience, restore their safety, heal their social and emotional wounds, and prevent future violence and delinquency. Funding can be used to develop and/or enhance support services for children exposed to violence to

reduce the adverse impact of violence on youth, families, and communities, and to help family-serving organizations better recognize and help families at risk for exposure to violence.

# **Statutory Authority**

34 U.S.C. 11171–11172; Department of Justice Appropriations Act, 2023, Pub. L. No. 117-328, 136 Stat. 4459, 4538.

#### **Specific Information**

Each year, nearly 60 percent of children in the United States are exposed to violence in their homes, schools, or communities[1]. Stressful life events such as children's exposure to violence, whether as victims or witnesses, is often associated with long-term physical, psychological, and emotional harm. This exposure can include witnessing or being a direct victim of bullying and harassment, physical abuse or neglect, physical and sexual assault, or community and school violence, including gang violence, interpersonal violence, and threats of harm. Research shows that exposure to violence within the first few years of childhood can affect the neurocognitive development of children and deprive them of as much as 10 percent of their potential intelligence (IQ). As they grow into adolescence, these children continue to be seriously and negatively impacted, often having difficulty in school, conflict and emotional detachment issues with peers and family members, using violence against others, and developing serious problems such as addiction, impulsive or reckless behavior, depression, or delinquency.[2] In a 2019 study on neighborhood violence, 6.8% of children aged 5-17 years were exposed to violence, with higher rates of exposure for Non-Hispanic black children (9.5%).[3] According to an article in The American Journal of Preventive Medicine, racial and ethnic disparities in violence may be linked to other prominent health disparities.[4] Despite the prevalence of exposure to violence among children and evidence of its intersection with future offending, the majority of youth impacted by violence do not receive timely help to mitigate its harmful effects. To address this exposure, this program focuses on building protective factors for children exposed to violence; increasing access to and providing evidence-based, culturally specific, trauma-informed specialized services/intervention(s) to support children and families who are impacted; as well as the sustainment of this work.

Exposure to violence often requires interventions that range from improving the environment of the child by enhancing protective factors, to reducing symptoms, to addressing underlying trauma and reflect the diversity of needs. According to the CDC, strategies such as strengthening economic supports to families, promoting social norms that protect against violence and adversity, connecting youth to caring adults and activities among others, can create safe, stable, nurturing relationships and environments for all children and families that can prevent Adverse Childhood Experiences (ACEs), build resiliency and help all children reach their full potential. [5] Other examples of

programming and strategies considered effective in addressing exposure to violence include but are not limited to Positive Behavioral Interventions and Support (PBIS), Social Emotional Learning Approaches, Cognitive-Behavioral Intervention for Trauma in Schools (CBITS), Youth Mental Health First Aid, Restorative Justice practices, youth mentoring, Youth Courts, Street Law, Gang Resistance and Education Training (G.R.E.A.T.), and Violence Free Zone.

Although the prevalence of children's exposure to violence is overwhelming and can impact children in a variety of ways, there is clear evidence that a comprehensive and coordinated approach to care can help children to heal and thrive. An integral recommendation from the Attorney General's National Task Force on Children Exposed to Violence report included the importance of developing coalitions of multidisciplinary stakeholders within communities to help comprehensively identify and address gaps and barriers in services for children and their families and assure a systemwide and coordinated response. Community collaboration and coordination across a variety of disciplines is critical to ensure adequate identification, screening and assessment, service delivery, and improved policy and decision-making on behalf of children exposed to violence and their families. Such multidisciplinary groups can enable children and families to receive more coordinated and effective case management and wraparound support services, reducing the long-term psychological effects of witnessing or suffering from violence and creating opportunities for children to be safe, healthy, and successful.

# Goals, Objectives, and Deliverables

#### Goals

The overall goal of the program is to build the capacity of families and communities to help children exposed to violence.

#### **Objectives**

An applicant should address all of the objectives listed below in the Goals, Objectives,

Deliverables, and Timeline web-based form.

- Improve family and community responses to children exposed to violence.
- Increase protective factors to reduce the traumatic impact of exposure to violence and prevent future violence, delinquency, and victimization.
- Build the capacity of communities to develop and implement prevention and early intervention strategies to support children exposed to violence and enhance wellness and healing.

#### **Deliverables**

Efforts to address and implement these deliverables should be discussed as part of the submitted application.

- Convene a multidisciplinary team of stakeholders (existing or newly created) to guide and inform the development of a comprehensive plan to address children exposed to violence.
- Develop and/or enhance an existing comprehensive plan to address children exposed to violence and its impact on community safety by the end of the first year of funding This plan should identify specific communities where services will be implemented based on available data and will be presented to OJJDP for review/ approval.
- Develop and implement trauma-informed, culturally appropriate approaches along the prevention and intervention continuum that address risk factors and build on protective factors to prevent and reduce the impact of exposure to violence on children and families in the target communities.
- Support the provision of evidence-based mental health services for children who experience trauma and exposure to violence.

To successfully address issues related to children exposed to violence, it is important for communities to build a comprehensive approach that will identify gaps as well as maximize and leverage existing and new resources. Applicants must propose and undertake their work through a multidisciplinary team of stakeholders, which may be either an existing collaborative group or one that is formed specifically for this project. This planning team should meet regularly throughout the project period to identify and address service gaps and barriers, create a blueprint for a comprehensive network of services to support children exposed to violence and their families, build the capacity of communities to help children exposed to violence, and prevent/reduce exposure to violent crime. Stakeholders on the team can include court personnel, juvenile justice agencies, law enforcement, school-based law enforcement, district attorneys, public defenders, child welfare and social services, mental health, county/local public sector leadership, school administrators, at-risk families and children, culturally specific programs, and faith-based and child-serving community organizations.

All applicants should include an attachment labeled "Planning Team" with a description of

the team structure, including names of participants on the team and the name of their agency, in addition to any letters of commitment or memoranda of understanding (MOUs) with the members/agencies.

OJJDP has an existing training and technical assistance (TTA) provider to support the OJJDP-funded sites addressing children exposed to violence. Sites funded through this solicitation are expected to work with this TTA provider that will provide guidance and consultation to the funded program sites. The TTA activities will address specific technical assistance on youth violence prevention and intervention, trauma-informed practices, collaborative engagement across systems, community partnership coordination, etc. Additionally, TTA will include individualized training and technical assistance, cross-site meetings, and trainings on evidence-based practices.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

The following application elements **must** be included in the application to meet the basic minimum requirements to advance to peer review and receive consideration for funding:

- Proposal Abstract
- Proposal Narrative
- Budget Web-Based Form (The web-based form includes the budget details and the budget narrative.)

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

# Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

The SF-424 must be submitted in Grants.gov. It is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. See the OJP Grant Application Resource Guide for additional information on completing the SF-424.

In Section 8F of the SF-424, please include the name and contact information of the individual **who will complete the application in JustGrants**. JustGrants will use this information (*email address*) to assign the application to this user in JustGrants.

**Intergovernmental Review:** This solicitation ("funding opportunity") **is not** subject to Executive Order (E.O.) 12372. In completing the SF-424, an applicant is to answer question 19 by selecting "Program is not covered by E.O. 12372."

#### Standard Applicant Information (JustGrants 424 and General Agency Information)

The "Standard Applicant Information" section of the JustGrants application is prepopulated with the SF-424 data submitted in Grants.gov. The applicant will need to review the Standard Applicant Information in JustGrants and make edits as needed. Within this section, the applicant will need to add ZIP codes for areas affected by the project; confirm their Authorized Representative; and verify and confirm the organization's unique entity identifier, legal name, and address.

# **Proposal Abstract**

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants webbased form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

#### **Proposal Narrative**

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision. Please note: Tables, charts, and graphs included in the proposal narrative can be created in a legible font smaller than 12 point and will count toward the page limit.

The Proposal Narrative must include the following sections:

#### a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address (e.g., children exposed to violence). The applicant should use data to provide evidence that the problem exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Any data or research referenced in the narrative should include information about the source of the data and/or a citation.

Applicants should describe the target population, to include the age to be served and the specific community/communities to be targeted with funded interventions. This section should also discuss any previous or current attempts to address the problem as well as identify current gaps/barriers in programming/services.

Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

#### b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete

the deliverables stated in the Goals, Objectives, and Deliverables section. OJJDP encourages applicants to select evidence-based practices for their programs. This section should also include details regarding any leveraged resources (cash or inkind) from local sources to support the project and discuss plans for sustainability beyond the grant period. Applicants should also discuss the role of the Planning Team and how it will guide the project.

**Please note:** Applicants that were funded under a previous version of the OJJDP Strategies To Support Children Exposed to Violence solicitation must ensure the proposal narrative indicates how the project design is an enhancement or expansion of previously funded program activities.

Applicants should describe their vision and plan for meaningfully and sustainably integrating youth and family partnership into their proposed project. Applicants should address any corresponding budget implications in their application's budget detail and budget narrative. For resources/guidance on effective youth and family partnership strategies and practices, click <a href="here">here</a>.

If an applicant believes that their project design is in no way amenable to incorporating youth and family partnership, the applicant should instead provide a detailed explanation and justification for excluding this element.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

#### c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

**Letters of Commitment:** If submitting a joint application, as described under Eligibility, applicants should provide signed and dated letters of commitment or memoranda of understanding for all key partners that include the following:

- Expression of support for the project and a statement of willingness to participate and collaborate with the project.
- Description of the partner's current role and responsibilities in the planning process and expected responsibilities when the project is operational.
- Estimate of the percentage of time that the partner will devote to the planning and operation of the project.

Letters of commitment may be addressed to the OJJDP Administrator. Letters of commitment should be signed and submitted as one separate attachment and labeled as "letters of commitment."

Only letters of commitment that are submitted by the due date and with the full application will be considered during the review process.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

The applicant will also enter the projected fiscal year and quarter that each objective and deliverable will be completed. Goals. The applicant should describe the project's intent to change, reduce, or eliminate the problem noted in the previous section and outline the project's goals.

Program Objectives. The applicant should explain how the program will accomplish its goals. Objectives are specific, quantifiable statements of the project's desired results. They should be measureable and clearly linked to the goal.

Deliverables. Project deliverables refer to outputs—tangible or intangible—that are submitted within the scope of a project.

Timeline. Applicants should submit a realistic timeline or milestone chart that indicates major tasks associated with the goals and objectives of the project, assigns responsibility for each, and plots completion of each task by month or quarter for the duration of the award, using "Year 1," "Month 1," "Quarter 1," etc., not calendar dates (see "Sample Project Timelines" here). # **Applicant Disclosure and Justification - DOJ High Risk Grantees**

# **How to Apply**

<u>Registration</u>: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

<u>Submission</u>: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Step 1: After registering with SAM, the applicant must submit the SF-424 and SF-LLL in Grants.gov at <a href="https://www.grants.gov/web/grants/register.html">https://www.grants.gov/web/grants/register.html</a> by the Grants.gov deadline. Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline. If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

**Step 2:** The applicant must then submit the **full application**, including attachments, in JustGrants at <u>JustGrants.usdoj.gov</u> by the JustGrants deadline.

Within 24 hours after receipt of confirmation emails from Grants.gov, the individual in Section 8F of the SF-424 will receive an email from <a href="DIAMD-NoReply@usdoj.gov">DIAMD-NoReply@usdoj.gov</a> with instructions on how to create a JustGrants account. #### **Merit Review Criteria**

Applications that meet the basic minimum requirements will be evaluated by peer reviewers on how the proposed project/program addresses the following criteria:

- 1. Description of the Issue (20%) evaluate the applicant's understanding of the program/issue to be addressed.
- 2. Project Design and Implementation (35%)- evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
- 3. Capabilities and Competencies (25%) evaluate the applicant's administrative and technical capacity to successfully accomplish the goals and objectives.
- 4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (10%) evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
- 5. Budget (10%) evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

#### Other Review Criteria/Factors

Other important considerations for OJJDP include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, evidence of a planning team, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

#### **Review Process**

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant entity. Among other things to help assess whether an applicant with one or more prior federal awards has a satisfactory record of performance, integrity, and business ethics, OJP checks whether the applicant entity is listed in SAM as excluded from receiving a federal award.
