Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding for an organization to develop and administer a subgrants program to initiate, sustain, and expand local and state Court Appointed Special Advocates (CASA) programs in communities across the nation, and to provide training and technical assistance services to assist local and state CASA organizations to apply for, implement, and administer their subawards over the life of the project period. This program furthers the DOJ's mission by strengthening the capacity of communities to protect children from abuse and neglect.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

OJJDP's guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will Ireat Children as Children; Serve Children at Home, With Their Families, in their Communities; and Open Up Opportunities for System-Involved Youth. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

Court appointed special advocates (CASAs) are trained volunteers appointed by the family or juvenile court to advocate for the best interests of children who have been victims of abuse or neglect. CASA volunteers ensure that the psychological, educational, and social needs of abused and neglected children in dependency courts are met and support the goal of achieving safe, stable, and permanent homes for these children.

These volunteers work with child welfare professionals, educators, and service providers to ensure that judges have the information needed to make the best decisions for each child.

With this solicitation, OJJDP will select an organization to develop and administer a subgrants program for local and state CASA programs. Subgrantees will use their awards to initiate, sustain, and expand CASA programs and provide CASA services in communities where representation rates are low, the numbers of abused and neglected children are high, and service systems are not meeting the needs of families and children. State CASA organization subgrantees may use their awards to strengthen their capacity to provide services to local programs. The successful applicant will also provide training and technical assistance services to help subgrant applicants and sub-awardees apply for, implement, and administer their subawards over the life of the project period.

Statutory Authority

34 U.S.C. § 20323

Goals, Objectives, and Deliverables

Goals

The goal of this program is to improve outcomes for children in the foster care system and to provide effective and timely advocacy for abused and neglected children in dependency courts. Under this program, this will be done by successfully issuing and managing subgrants to local and state CASA organizations around the nation. These programs will work to increase the numbers of children receiving services from CASA programs.

Objectives

- To design and implement a competitive subgrant funding strategy to support local and state CASA programs nationwide.
- To administer and oversee subgrants to initiate, sustain, and expand local and state CASA programs with a focus on distributing subgrants to localities that have no existing CASA program.
- To design and implement training and technical assistance services to help local and state CASA organizations apply for, implement, and administer their subawards.

Deliverables

- Requests for proposals (RFPs) to support local and state CASA programs.
- Training and technical assistance materials for subgrant applicants and subgrantees to assist with applying for and implementing subgrant funding.
- Materials related to subgrant applicant recruitment, application submission, review criteria, and decision-making.

These items must be addressed in the program narrative, timeline, and budget, including specifics regarding how the successful applicant will develop the subgrant funding announcement and application process, application review and decision-making, awarding procedures, and monitoring of these subgrants:

- A minimum of 75 percent of the overall award (or \$10,125,000) must be allocated to subgrants for local and state CASA organizations.
- The applicant must plan to issue subgrants to a minimum of 125 state and local CASA programs around the nation during the course of the project period. At least 30 percent of these should be to sites that lack access to an existing CASA program and to support expansion of existing programs to increase access. Subgrant categories required are listed below:
 - <u>Program Development</u> Support the development of CASA programs in localities with demonstrated need that lack access to an existing program.
 - <u>Program Expansion</u> Increase access in underserved areas through expansion of existing programs, increase staff resources to support increased number of children served, and increase state growth and expansion.
 - Core Support/Needs-Based Support unmet operational costs and other unique needs of CASA programs to ensure continued access to services for children.
 - Recruitment of Volunteers With Lived Experience Support efforts related to recruitment of volunteer advocates that are reflective of the communities and children served and have lived experience, and/or support projects targeted at creating a culture of inclusiveness and equitable practices, and building the capacity of the workforce to provide enhanced trauma informed and culturally responsive services.
- The applicant should plan to release an RFP no later than January 5, 2024, and begin issuing subgrants by April 1, 2024. Release of subsequent RPFs and issuance of subawards can continue through the life of the project period. OJJDP review and approval are required for all RFPs.
- Subgrant amounts may range from \$30,000 to \$150,000, depending upon the need, size of the organization and volunteer base, project period, and capacity of the subgrant organization to administer the funds. The applicant should propose subgrant funding amounts reflective of category purpose and scope (i.e., accounting for a broader range of funding amounts for development and expansion projects).

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

OJJDP Training and Technical Assistance Awardee Standards

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants webbased form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The proposal narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address (i.e., high rates of child abuse and neglect, absence of CASA programs). The applicant should use data to provide evidence that the problem exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe the target population and any previous or current attempts to address the problem. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions.

b. Project Design and Implementation

The applicant should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. The applicant should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. The applicant should detail the funding strategy to be implemented, including specifics regarding the application process, review of applications, decisionmaking, award procedures, and monitoring. In addition, this section should describe how the applicant will prepare local and state CASA organizations to apply for subaward funding, how they will work effectively to issue funds in a timely manner, and how they will support the subawardees in accessing funds and implementing their programs.

Note the following required elements for the funding strategy and refer to the Goals, Objectives, and Deliverables section for specific details:

- A minimum of 75 percent of the overall award must be allocated to subgrants.
