VISION STATEMENT

OJJDP envisions a nation where our children are free from crime and violence. If they come into contact with the justice system, the contact should be rare, fair, and beneficial to them.

MISSION STATEMENT

OJJDP provides national leadership, coordination, and resources to prevent and respond to youth delinquency and victimization. The Office helps states, localities, and tribes develop effective and equitable juvenile justice systems that create safer communities and empower youth to lead productive lives.

It is important to note that accurate data rely on correct data tracking and entry by the grantees and those agencies reporting to grantees, as such the data and analysis findings provided reflect the information as reported. These analytical findings make no claims of causation or demonstrate evidence of program effectiveness, and, as with all performance data, readers must use caution when interpreting the results, as factors other than the program may have contributed to the performance outcomes reported.

Data during the July to December 2021 activity period was impacted by the Covid-19 global pandemic. Grantees and service providers experienced a disruption to services, which raised obstacles for service delivery and data collection. The following data reflect services adapted to and provided during the Covid-19 pandemic.

INTRODUCTION

The Training and Technical Assistance (TTA) program, administered by the Office of Juvenile Justice and Delinquency Prevention (OJJDP), supports the role of TTA service providers in OJJDP's national efforts to reduce youth crime and victimization, and to improve the juvenile justice system. TTA, as defined by OJJDP, is the planning, development, and evaluation of activities designed to achieve specific learning objectives, resolve problems, and foster the application of innovative approaches to juvenile delinquency and victimization. OJJDP funds TTA to provide a wealth of diverse services such as, building jurisdiction capacity, implementing evidence-based programs, and advancing juvenile justice system improvements efforts.

OJJDP requires TTA grantees to report on performance measures to demonstrate whether the TTA program achieved its goals and to improve program decisions. OJJDP's TTA grantee network consists of experts, program directors, and staff who have made significant contributions in knowledge sharing and capacity building for law enforcement, officials, prosecutors, and other professionals working in the juvenile justice field and child welfare. This memo presents the TTA program activities occurring between July and December 2021 and highlights grantee results achieved with OJJDP funding.

OVERVIEW OF AWARD INFORMATION

Between July and December 2021, OJJDP's TTA program funded 36 awards, with 97 percent completing their reporting requirements during this period. Thirty-one TTA awards were operational (expending grant funds during the period). The total available funding to TTA organizations during the activity period exceeded \$81.4 million, and most awards supported nonprofit, community-based organizations. Other organizations receiving funds were law enforcement agencies, government agencies, and other juvenile justice organizations.

EVIDENCE-BASED PROGRAMS

OJJDP encourages grantees to use evidence-based practices and programs shown through rigorous evaluation and replication to be effective at preventing or reducing juvenile delinquency or related risk factors. OJJDP's TTA program promotes innovative approaches to program design and training delivery for juvenile justice practitioners, including officers, attorneys, and other child-serving professionals. TTA grantees provide problem assessments, strategic planning, and evidence-based programming to implement in-person, online, and hybrid learning sessions to strengthen multidisciplinary responses to juvenile justice issues such as youth violence and victimization, restorative justice, court services, and family engagement. During the July–December 2021 activity period, 23 percent of TTA awards used one or more evidence-based programs or practices.

TRAINING AND TECHNICAL ASSISTANCE ACTIVITIES

TTA grantees focus on the planning, development, and delivery of training activities such as in-person or virtual training workshops, producing toolkits, and developing job aids and apps, designed to achieve specific learning objectives. TTA grantees aim to enhance child serving and juvenile justice systems by fostering the application of innovative approaches to juvenile delinquency, child welfare, and victimization. Figure 2 presents data on program training activities, which include TTA requests received, people trained, and program materials developed. Collectively, grantees received a total of 170 training requests and 2,853 requests for technical assistance during the activity period.

TRAINING AND TECHNICAL ASSISTANCE OUTCOMES

The primary goals of TTA programs are to increase training recipients' knowledge of specific program areas and improve overall program operations based on TTA. Program areas that commonly report operational improvements include child abuse investigations, forensic interviewing, juvenile justice reform, and community-based youth violence prevention. Common, tracked outcomes include an increase in an individual's knowledge post-training, number of individuals trained, and percentage of organizations reporting operational improvements. Figure 3 presents data on increased knowledge and improvements in program operations. Eighty percent of individuals exhibited increased knowledge of the program area after receiving training. Forty-seven percent of organizations reported improvements in operations based on TTA, and 33 percent of programs served by TTA reported implementing an evidence-based program or practice.

CONCLUSION

Through the TTA program, OJJDP supports the central role of TTA in its national effort to improve the juvenile justice child serving systems by designing and providing training to increase OJJDP-defined program outcomes. TTA grantees develop innovative seminars, workshops, and toolkits for juvenile justice professionals, including law enforcement, attorneys, and other child-serving practitioners and multidisciplinary teams. Training subject matter includes child abuse investigations, missing and exploited children, community-based youth violence prevention, and juvenile justice reform. Successful TTA is measured in part by an increase in learning or knowledge following training and an improvement in program operations. The results reported by OJJDP's TTA grantees for the July–December 2021 activity period demonstrate a positive impact of TTA for practitioners in the juvenile justice field and child welfare.

During the activity period, 31 TTA awards were operational and 28,258 people were trained with the support of OJJDP funding. Additionally, 80 percent of people trained reported having increased knowledge post-training and 47 percent of organizations reported improvements in operations based on the TTA provided. The performance measures represent a snapshot of the number of people impacted by the TTA services. These results demonstrate the positive impact of OJJDP'S TTA program at improving the outcomes for youth and juvenile justice system involvement.
