Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office of Juvenile Justice and Delinquency Prevention](#) (OJJDP) seeks applications for funding under the fiscal year (FY) 2023 Victims of Child Abuse Act Training and Technical Assistance for Child Abuse Professionals program. This program furthers the DOJ's mission by providing funding for the development and implementation of a national training and technical assistance program for child abuse professionals and to promote a multidisciplinary response to child abuse cases.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#), which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Eligible Applicants:

National organizations that—

- have a diverse portfolio of training and technical assistance resources for the diverse professionals who respond to child abuse, including a digital library to promote evidence-informed practice, and
- have demonstrated experience in providing training and technical assistance for child abuse professionals, especially law enforcement officers, child protective service workers, prosecutors, forensic interviewers, medical professionals, victim advocates, and mental health professionals.

OJJDP will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

[OJJDP's](#) guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will [Treat Children as Children](#); [Serve Children at Home, With Their Families, in their Communities](#); and [Open Up Opportunities for System-Involved Youth](#). OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful partnership and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to provide funding for the development and implementation of training and technical assistance for child abuse professionals for the purpose of promoting the effective delivery of the evidence-informed Children's Advocacy Center Model and the multidisciplinary response to child abuse.

Statutory Authority

This program is authorized under the Victims of Child Abuse Act (VOCA), 34 U.S.C. § 20305

Specific Information

OJJDP seeks proposals that support efforts to develop and operate a model national training and technical assistance program for child abuse professionals to enhance the coordinated multidisciplinary investigation and response to child abuse and increase the quality of intervention and treatment services available to child abuse victims. The successful applicant will be responsible for providing training and technical assistance, developing and disseminating publications, and implementing methods to assess training and technical assistance provided. The successful applicant will be expected to collaborate with and across all other VOCA programs to strategically expand the reach and enhance the program activities under each VOCA program award. Other VOCA programs include the Regional Children's Advocacy Centers, Tribal Children's Advocacy Center Training and Technical Assistance, Training and Technical Assistance for Child Abuse Prosecutors, Children's Advocacy Centers Membership and Accreditation, and Children's Advocacy Centers Subgrants.

Goals, Objectives, and Deliverables

Goals

The program's goal is to enhance the coordinated multidisciplinary approach to investigating and prosecuting child abuse and improve the capacity of child abuse professionals to effectively respond to child maltreatment. OJJDP seeks proposals that support efforts to provide information regarding improved child interview techniques—more specifically, techniques related to advanced interviewing, thorough investigative methods, interagency coordination, and effective court preparation and presentation.

Objectives

An applicant should address all of the objectives listed in the Goals, Objectives, Deliverables, and Timeline web-based form.

To achieve its goal, OJJDP has established the following objectives for this program:

- Develop training opportunities for child abuse multidisciplinary teams (MDTs) and professionals. These teams may include but are not limited to law enforcement, prosecutors, service providers, Child Protective Services (CPS) investigators, social workers, and adult and juvenile probation officers.
- Provide technical assistance for child abuse professionals and MDTs to enhance the coordinated multidisciplinary response to child abuse.
- Develop publications and resources for child abuse professionals to enhance the coordinated multidisciplinary response to child abuse.

Training and technical assistance proposed should occur at the local, state, regional, and national levels and be delivered through a systematic, coordinated, and customized approach developed in partnership with the other VOCA-funded programs, as noted in the deliverables below.

Deliverables

The applicant is expected to deliver the activities and products listed below under this project. While these deliverables are to be developed during the course of the project, applicants should propose an initial 3-year training and technical assistance strategic plan to be informed and enhanced by the deliverables below.

- Conduct an annual assessment of key stakeholders in the field to identify gaps and emerging training and technical assistance needs to improve the coordinated multidisciplinary response to child abuse and increase the capacity of child abuse professionals to address child maltreatment. Key stakeholders should include, but are not limited to, law enforcement, prosecutors, service providers, CPS investigators, social workers, and juvenile justice system professionals.
- Develop and implement an annual training and technical assistance strategic plan informed by the needs assessment. The plan should detail the products and deliverables that will be produced to address the gaps across the above multiple stakeholder groups as well as propose criteria for deciding the communities in which to devote project resources.
- Provide training sessions (onsite, cross-site, online/web based, etc.) for child abuse professionals at the local, state, regional, and national levels. The applicant will propose the topics, types, quantity, duration, audiences, timing, and means of delivery of training sessions; and identify trainers with relevant expertise and audiences with significant need. The applicant will include plans for evaluating training sessions, to include measuring changes in participants' knowledge, attitude, and behavior.
- Develop publications and resources designed to enhance the coordinated multidisciplinary response to child abuse. The applicant will indicate the topics, types, quantity, audiences, and production schedule for proposed publications; and identify the authors and contributors. The applicant will create a plan to disseminate publications and measure their impact by, at a minimum, collecting data on the number of copies disseminated, the number of times online versions are accessed, and the types of users.
- Strategically collaborate with the VOCA-funded program partners to produce and annually maintain and update a 5-year strategic plan and a related operational plan to align efforts, maximize resources, and outline clear roles and responsibilities across the partners. Plans need to be delivered to OJJDP for review and approval by the 10th month of each year of the project following award. The successful applicant will be expected to participate in regularly scheduled VOCA program partner meetings with OJJDP.

The successful applicant is expected to coordinate its training and technical assistance activities with the previous training and technical assistance provider, VOCA regional CACs, and all other VOCA grantees, as OJJDP directs. Specifically, OJJDP will expect the successful applicant to leverage resources by incorporating deliverables previously developed under this program into its training and technical assistance project design. In addition, OJJDP may direct the successful applicant to enhance, disseminate, or build on existing program deliverables.

OJJDP training and technical assistance awardee standards. OJJDP has developed the [Core Performance Standards for Training, Technical Assistance, and Evaluation](#) to promote among providers the consistency and quality of OJJDP-sponsored training and technical assistance and to advance common expectations of performance excellence. The standards present minimum expectations that providers must meet for effective practice in the planning, coordination, delivery, and evaluation of training. Award recipients must coordinate with OJJDP's National Training and Technical Assistance Center (NTTAC) in the assessment and delivery of services to ensure the effective use of OJJDP grant funding.

Requirements related to coordination of activities will include, but are not limited to:

- **Coordination with OJJDP NTTAC.** OJJDP requires all training and technical assistance projects to coordinate their activities with OJJDP NTTAC by complying with all OJJDP/NTTAC protocols to ensure coordinated delivery of services among providers and the effective use of OJJDP grant funding. OJJDP reserves the right to modify these protocols at any time with reasonable notice to the grantee prior to project completion.
- **OJJDP-funded webinars.** The award recipient must comply with OJJDP's Webinar Guidelines, as described in the core performance standards. Minimally, OJJDP training and technical assistance providers will submit information to OJJDP NTTAC in advance of all events for the online calendar, use the approved OJJDP presentation template, and record events and provide the final files which are compliant with Section 508 of the Workforce Rehabilitation Act to OJJDP or OJJDP's representative. - **Training information sharing.** OJP will collect information from its program offices on OJP-funded training and technical assistance events. 1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally

specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision. Pages should be numbered “1 of 30,” etc. The tables, charts, pictures, etc., including all captions, legends, keys, subtext, etc., may be single-spaced and will count in the 30-page limit. Material required under the Budget and Budget Narrative and Additional Application Components sections will not count toward the program narrative page count. Applicants may provide bibliographical references as a separate attachment that will not count toward the 30-page program narrative limit.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the need for a national training and technical assistance program for child abuse professionals. The applicant should describe the current state of the field and needs assessment information using data to provide evidence that the problem (i.e., workforce training needs of child abuse professionals) exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Applicants should describe the target population and any previous or current attempts to address the problem.

Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. Any data or research referenced in the narrative should include information about the source of the data and/or a citation. While OJJDP expects applicants to review the

research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should submit as part of their application an initial, foundational training and technical assistance strategic plan and describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. OJJDP encourages applicants to select evidence-based practices for their programs.

This section should also include details regarding any leveraged resources (cash or in-kind) from local sources to support the project and discuss plans for sustainability beyond the grant period.

Applicants should describe their vision and plan for meaningfully and sustainably integrating youth and family partnership into their proposed project. Applicants should address any corresponding budget implications in their application's budget detail and budget narrative. If an applicant believes that their project design is in no way amenable to incorporating youth and family partnership, the applicant should instead provide a detailed explanation and justification for excluding this element.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including

details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (5%) - evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
5. Budget (5%) - evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

Review, Certify and Submit Application in JustGrants

- Any validation errors will immediately display on screen after submission.
- Correct validation errors, if necessary, and then return to the “Certify and Submit” screen to submit the application. Access the [Application Submission Validation Errors Quick Reference Guide](#) for step-by-step instructions to resolve errors prior to submission.
- Once the application is submitted and validated, a confirmation message will appear

at the top of the page. Users will also receive a notification in the “bell” alerts confirming submission.
