The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) is seeking applications for the FY 2015 Initiative to Develop Juvenile Reentry Measurement Standards. The provider will work with OJJDP to develop, test, and disseminate a set of practice and outcome measures for juvenile reentry that are guided by current juvenile reentry research, data collection, and performance measurement knowledge and practice. This program furthers the Department's mission by establishing a model to assist jurisdictions in measuring services and outcomes in juvenile reentry, aligning measurement practices across jurisdictions, and improving the assessment of juvenile reentry services' impact on public safety and youth outcomes.

OJJDP FY 2015 Initiative To Develop Juvenile Reentry Measurement Standards

Eligibility

Eligible applicants are states (including territories), units of local government, tribes (i.e., federally recognized Indian tribal governments, as determined by the Secretary of the Interior), nonprofit and for-profit organizations (including tribal nonprofit or for-profit organizations), and institutions of higher education (including tribal institutions of higher education). For-profit organizations must agree to forgo any profit or management fee. Foreign governments, foreign organizations, and foreign institutions of higher education are not eligible to apply.

OJJDP welcomes applications that involve two or more entities; however, one eligible entity must be the applicant and the other(s) must be proposed as subrecipient(s). The applicant must be the entity with primary responsibility for conducting and leading the project. If successful, the applicant will be responsible for monitoring and appropriately managing any subrecipients or, as applicable, for administering any procurement subcontracts that would receive federal program funds from the applicant under the award. OJJDP will consider only one application per lead applicant; however, subrecipients may be part of multiple proposals.

OJJDP may elect to make awards for applications submitted under this solicitation in future fiscal years, dependent on the merit of the applications and on the availability of appropriations. For additional eligibility information, see Section <u>C. Eligibility Information</u>.

Deadline

Applicants must register with <u>Grants.gov</u> prior to submitting an application. All applications are due to be submitted and in receipt of a successful validation message in Grants.gov by 11:59 p.m. eastern time on June 10, 2015.

OJJDP FY 2015 Initiative to Develop Juvenile Reentry Measurement Standards (CFDA #16.812)

A. Program Description

Overview

Under this solicitation, OJJDP is seeking proposals to develop standards to document and measure juvenile reentry service delivery, practices, and outcomes. These measurement standards will identify and define key indicators of effective reentry practice and successful outcomes for juveniles starting at the confinement decision (pre- and post-adjudication), moving through reintegration into the community, and for a meaningful period post-release. The practice measures should be flexible and address variations in types and length of confinement. The individual-level outcomes should include both measures of public safety (e.g., crime and recidivism) and positive developmental milestones (e.g., reenrollment in school, family engagement) for youth reentering the community. Current juvenile reentry research, data collection, and performance measurement knowledge and practice should quide the measurement standards developed under this initiative. The successful applicant will pilot test the measurement standards and include final, recommended measurement standards that incorporate the results of the pilot testing and recommendations for implementation considerations. The measurement standards should be scalable and relevant to sites that may vary widely in structure, organization, and administration of reentry supervision and services. OJJDP expects that the final measurement standards will help agencies with jurisdiction over juvenile reentry identify measures to consistently and reliably assess service delivery and youth and community outcomes. It may also inform broader audiences, such as key decisionmakers in related social service agencies, policy makers, and the public.

Authorizing Legislation: This program is authorized pursuant to Section 211 of the Second Chance Act, Pub. L. No. 110-199; and paragraph (21) under the State and Local Law Enforcement heading in the Department of Justice Appropriations Act, 2015, Pub. L. No. 113-235, 128 Stat. 2135, 2193.

Program-Specific Information

Currently, there is wide variation in how juvenile justice agencies identify, implement, and use measures to:

- track and understand the institutional experiences of youth.
- determine what transitional supports or services youth receive while in out-of-home placement and during their transition back into the community.

assess youth outcomes after being released from residential placement facilities.¹

While some states and localities may have exemplary measurement systems, others would benefit from additional guidance regarding what to measure and how.² This program seeks applications to develop juvenile reentry measurement standards that would better capture the service delivery or supports (including institutional experiences) and outcomes in juvenile reentry, starting at the confinement decision and moving into the successful reintegration into the community. The practice measures should be flexible and address variations in types and length of confinement. The juvenile outcomes should include both measures of public safety (e.g., crime and recidivism) and positive developmental milestones (e.g., reenrollment in school, family engagement) for youth reentering the community.

The measurement standards should be based in juvenile justice and youth development research and knowledge, and practice in local performance measurement and data collection. The successful applicant will also work with OJJDP to ensure the measurement standards incorporate, build upon, and coordinate with other current national research and measurement initiatives related to juvenile reentry. Examples include efforts that the National Reentry Resource Center or other national or federally supported reentry initiatives, such as those highlighted in Reforming Juvenile Justice: A Developmental Approach, have undertaken.

The final measurement standards should also include implementation considerations that address possible barriers (e.g., administrative, technical) and specifically incorporate knowledge of data collection infrastructure, feasibility in measurement use, likelihood of implementation, usefulness of potential data to local practice improvement, and state or national indicators. Before providing final recommended measurement standards, the successful applicant will pilot test the developed model and incorporate adjustments based on results of those pilot tests.

Juvenile reentry. OJJDP defines reentry as a process that begins at the confinement decision (pre- or post-adjudication) and includes the assessment, services, and release planning that occurs in the facility and the services and supervision a youth receives upon reentry and ends with his or her successful reintegration into the community. It includes both secure confinement and nonsecure residential placement.

Goals, Objectives, Deliverables, and Expected Products

The goal of this initiative is to develop measurement standards for juvenile reentry practices that will help guide states, and localities in assessing, measuring, and understanding juvenile reentry practice and outcomes.

In developing these measurement standards for juvenile reentry practices, the successful applicant should employ a systematic and research-based approach. The successful applicant will complete four central objectives or activities:

- Activity 1: Synthesizing and analyzing the current literature in implementation science, juvenile reentry, and youth development with current practice in juvenile reentry and data collection across the nation to identify key indicators for measuring the juvenile reentry process. The award recipient will determine the methodology and documentation format for this synthesis in consultation with OJJDP. The synthesis will include, but is not limited to identifying:
 - Implementation and developmentally appropriate indicators for: (1) risk and needs assessment; (2); (3) organizational or institutional capacity and structure, including staffing; (4) cross-system services and/or coordination; (5) post-release services and supervision; and (6) family engagement and support.
 - Youth outcome indicators for: (1) recidivism/public safety and (2) positive youth developmental indicators across individual, family, social, and community domains.
 - Potential cost or cost-benefit indicators.
- Activity 2: Translating the key indicators identified under Activity 1 to user-friendly and understandable draft juvenile reentry measurement standards. This should include providing an initial draft of the measurement standards to OJJDP for review and comment before submitting the complete first draft of the measurement standards. In consultation with OJJDP, the award recipient may propose to deliver these standards in traditional formats (such as a word processing document); however, OJJDP is also interested in proposals that use less traditional formats (such as online, interactive designs). The draft standards should consider local, state, and national usefulness of the indicators and feasibility in implementation. The draft standards should include, but are not limited to addressing:
 - o individual, family, social, and community domains.
 - model measures.
 - definitions.
 - data collection, infrastructure, or system requirements or recommendations.
 - implementation considerations.
 - o enhancement or variation possibilities.
 - references to evidence or underlying research.
- Activity 3: Pilot testing the measurement standards. This pilot testing should address
 appropriate evaluation, privacy, and human subjects' regulations (see additional
 information under Human Subjects and Privacy Certificate). The pilot testing should
 gather systematic feedback on the standards, including but not limited to the clarity of
 the measures, usefulness of the standards, and applicability and adaptability to local

implementation. At this time, OJJDP does not anticipate a formal validation process; however, the applicant should address whether that appears feasible within the scope of the project and budget available. The application should also provide for:

- a proposed pilot testing implementation plan provided to OJJDP for review and comment prior to beginning the pilot test.
- testing across several agency types, institutional settings, and reentry system approaches.
- synthesizing the pilot testing findings into a summary document.
- Activity 4: Revising and providing final recommended measurement standards to OJJDP that incorporate the findings and feedback gathered during the pilot phase. This should include providing draft final measurement standards to OJJDP for review and comment before submitting the final version. The final measurement standards should include:
 - o a final version of the draft capturing all items from Activity 2.
 - a delivery mechanism or platform that is scalable, flexible, and transferable to maximize its utility across a wide range of agencies with jurisdiction over juvenile reentry. This delivery mechanism will be finalized in coordination with OJJDP and, to the extent possible, integrate within current available web-based and training and technical assistance platforms.

Deliverables. Proposals should describe all products that the grantee will produce from the project. Successful applicants will submit relevant reports and deliverables to OJJDP. These will be a part of their progress reporting or special reports and include the following:

- practitioner friendly overview documents highlighting the project's goals and objectives, as OJJDP requires. (Refer to OJJDP News @ a Glance and JuvJust publications for examples of the type of documents requested, www.ojjdp.gov/enews/enews.html.)
- drafts of the measurement standards and pilot testing, as noted in activities 1-4 noted above, including:
 - o literature synthesis approach.
 - initial and final measurement standards drafts.
 - o pilot testing implementation plan and results.
 - draft final and final measurement standards and platform/delivery mechanism for wide dissemination that incorporate the findings from the pilot testing.
- a detailed progress report to OJJDP every 6 months describing the status of the
 evaluation, methodological and implementation issues, progress toward the project
 goals, and any other issues that are relevant to the study's completion.

- a final, detailed report documenting the project and its findings. This publication should include an executive summary and be suitable for a nontechnical audience, to be disseminated at OJJDP's discretion.
- one or more scholarly products to result from each award under this solicitation taking the form of one or more published, peer-reviewed, scientific journal articles and/or, if appropriate, law review journal articles, book chapter(s), and book(s) in the academic press.

B. Federal Award Information

OJJDP expects to make one award of as much as \$750,000 for a 36-month project period, beginning on October 1, 2015.

OJJDP may, in certain cases, provide supplemental funding in future years to awards under its research, development, and evaluation solicitations. Important considerations in decisions regarding supplemental funding include, among other factors, the availability of funding, strategic priorities, OJJDP's assessment of the quality of the management of the award (for example, timeliness and quality of progress reports), and OJJDP's assessment of the progress of the work funded under the award.

All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.

Type of award³. OJJDP expects to make any award from this solicitation in the form of a cooperative agreement, which is a particular type of grant used if OJJDP expects to have ongoing substantial involvement in award activities. Substantial involvement includes direct oversight and involvement with the grantee organization in implementation of the grant, but does not involve day-to-day project management. See <u>Administrative</u>, <u>National Policy</u>, and <u>Other Legal Requirements</u>, under Section <u>F. Federal Award Administration Information</u>, for details regarding the federal involvement anticipated under an award from this solicitation.

As discussed <u>later in the solicitation</u>, important rules (including limitations) apply to any conference/meeting/training costs under cooperative agreements.

Please note: OJJDP will require any recipient of an award under this solicitation to comply with Department of Justice regulations on confidentiality and human subjects' protection. See "Evidence, Research, and Evaluation Guidance and Requirements" under "Solicitation Requirements" in the <u>OJP Funding Resource Center</u>. Also review the Research and Evaluation Independence and Integrity section on page 20.

Financial management and system of internal controls. If selected for funding, the award recipient must:

(a) Establish and maintain effective internal control over the federal award that provides reasonable assurance that the nonfederal entity is managing the federal award in compliance with federal statutes, regulations, and the terms and conditions of the federal award. These internal controls should be in compliance with guidance in "Standards for

Internal Control in the Federal Government" issued by the Comptroller General of the United States and the "Internal Control Integrated Framework", issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO).

- (b) Comply with federal statutes, regulations, and the terms and conditions of the federal awards.
- (c) Evaluate and monitor the nonfederal entity's compliance with statute, regulations, and the terms and conditions of federal awards.
- (d) Take prompt action when instances of noncompliance are identified including noncompliance identified in audit findings.
- (e) Take reasonable measures to safeguard protected personally identifiable information and other information the federal awarding agency or pass-through entity designates as sensitive or the nonfederal entity considers sensitive consistent with applicable federal, state, and local laws regarding privacy and obligations of confidentiality.

In order to better understand administrative requirements and cost principles, award applicants are encouraged to enroll, at no charge, in the Department of Justice Grants Financial Management Online Training available here.

Budget information. What will not be funded:

- proposals primarily to purchase equipment, materials, or supplies. (A budget may include these items if they are necessary to conduct research, development, demonstration, evaluation, or analysis.)
- proposals that are not responsive to this specific solicitation.
- any biomedical or behavior control experimentation on individuals or any research involving such experimentation.

Cost sharing or match requirement. This solicitation does not require a match. However, if a successful application proposes a voluntary match amount, and OJP approves the budget, the total match amount incorporated into the approved budget becomes mandatory and subject to audit.

Preagreement cost approvals. OJP does not typically approve preagreement costs; an applicant must request and obtain the prior written approval of OJP for all such costs. If approved, pre-agreement costs could be paid from grant funds consistent with a grantee's approved budget, and under applicable cost standards. However, all such costs prior to award and prior to approval of the costs are incurred at the sole risk of an applicant. Generally, no applicant should incur project costs *before* submitting an application requesting federal funding for those costs. Should there be extenuating circumstances that appear to be appropriate for OJP's consideration as pre-agreement costs, the applicant should contact the point of contact listed on the title page of this announcement for details on the requirements for submitting a written request for approval. See the section on Costs Requiring Prior Approval in the Financial Guide, for more information.

Limitation on use of award funds for employee compensation; waiver. With respect to any award of more than \$250,000 made under this solicitation, recipients may not use federal funds to pay total cash compensation (salary plus cash bonuses) to any employee of the award recipient at a rate that exceeds 110 percent of the maximum annual salary payable to a member of the Federal Government's Senior Executive Service (SES) at an agency with a Certified SES Performance Appraisal System for that year⁴. The 2015 salary table for SES employees is available at the Office of Personnel Management website. Note: A recipient may compensate an employee at a greater rate, provided the amount in excess of this compensation limitation is paid with non-federal funds. (Any such additional compensation will not be considered matching funds where match requirements apply.)

The OJJDP Administrator may exercise discretion to waive, on an individual basis, the limitation on compensation rates allowable under an award. An applicant requesting a waiver should include a detailed justification in the budget narrative of the application. Unless the applicant submits a waiver request and justification with the application, the applicant should anticipate that OJP will request the applicant to adjust and resubmit the budget.

The justification should include the particular qualifications and expertise of the individual, the uniqueness of the service the individual will provide, the individual's specific knowledge of the program or project being undertaken with award funds, and a statement explaining that the individual's salary is commensurate with the regular and customary rate for an individual with his/her qualifications and expertise, and for the work to be done.

Prior approval, planning, and reporting of conference/meeting/training costs. OJP strongly encourages applicants that propose to use award funds for any conference-, meeting-, or training-related activity to review carefully – before submitting an application – the OJP policy and guidance on "conference" approval, planning, and reporting. OJP policy and guidance (1) encourage minimization of conference, meeting, and training costs; (2) require prior written approval (which may affect project timelines) of most such costs for cooperative agreement recipients and of some such costs for grant recipients; and (3) set cost limits, including a general prohibition of all food and beverage costs.

Costs associated with language assistance (if applicable). If an applicant proposes a program or activity that would deliver services or benefits to individuals, the costs of taking reasonable steps to provide meaningful access to those services or benefits for individuals with limited English proficiency may be allowable. Reasonable steps to provide meaningful access to services or benefits may include interpretation or translation services where appropriate.

C. Eligibility Information

Eligibility. For additional eligibility information, see the title page.

Limit on number of applications submissions. If an applicant submits multiple versions of the same application, OJJDP will review <u>only</u> the most recent system-validated version submitted. For more information on system-validated versions, see <u>How To Apply</u>.

D. Application and Submission Information

What an Application Should Include

Applicants should anticipate that if they fail to submit an application that contains all of the specified elements, it may affect negatively the review of their application; and, should a decision be made to make an award, it may result in the inclusion of special conditions that preclude the recipient from accessing or using award funds pending satisfaction of the conditions.

Moreover, applicants should anticipate that applications determined to be nonresponsive to the scope of the solicitation, or that do not include the application elements that OJJDP has designated to be critical, will neither proceed to peer review nor receive further consideration. Under this solicitation, OJJDP has designated the following application elements as critical: Program Narrative, Budget Detail Worksheet, Budget Narrative, and resumes/curriculum vitae of key personnel. For purposes of this solicitation, key personnel means the principal investigator or project director and all coprincipal investigators. Please review the "Note on File Names and File Types" under How To Apply to be sure applications are submitted in permitted formats.

OJP strongly recommends that applicants use appropriately descriptive file names (e.g., "Program Narrative," "Budget Detail Worksheet and Budget Narrative," "Timelines," "Memoranda of Understanding," "Resumes") for all attachments. Also, OJP recommends that applicants include resumes in a single file.

1. Information to Complete the Application for Federal Assistance (SF-424)

The SF-424 is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. Grants.gov and OJP's Grants Management System (GMS) take information from the applicant's profile to populate the fields on this form. When selecting "type of applicant," if the applicant is a for-profit entity, select "For-Profit Organization" or "Small Business" (as applicable).

Intergovernmental review. This funding opportunity (program) **is not** subject to <u>Executive Order 12372</u>. (In completing the SF-424, applicants are to make the appropriate selection in response to question 19 to indicate that the "Program is not covered by E.O. 12372.")

2. Project Abstract

The project abstract is an important part of the application and serves as an introduction to the proposed project. OJJDP uses the project abstract for a number of purposes, including assignment of the application to an appropriate review panel. If the application

is funded, the project abstract typically will become public information and be used to describe the project.

Applications should include a high-quality project abstract that summarizes the proposed project in 250-400 words. Project abstracts should be—

- Written for a general public audience.
- Submitted as a separate attachment with "Project Abstract" as part of its file name.
- Single-spaced, using a standard 12-point font (Times New Roman) with 1-inch margins.

The abstract should include a description of:

- the purpose of the project, the problem to be addressed, and the anticipated relevance to juvenile justice and juvenile reentry policy, practice, and theory.
- a brief description of the proposed techniques for the methodology to develop and test the measurement standards, addressing each of the four key activities identified under Goals, Objectives, and Deliverables on pages 5-8.
- potential pilot test study sites, including number of subjects and other relevant attributes and the techniques proposed for assessing the likelihood of and potential barriers to broader national implementation.
- the expected deliverables identified under Goals, Objectives, and Deliverables on page 7.

As a separate attachment, the project abstract will **not** count against the page limit for the program narrative.

Project abstracts should follow the <u>detailed template</u> (including the detailed instructions as to content).

Permission to share project abstract with the public. It is unlikely that OJJDP will be able to fund all promising applications submitted under this solicitation, but it may have the opportunity to share information with the public regarding promising but unfunded applications, for example, through a listing on a webpage available to the public. The intent of this public posting would be to allow other possible funders to become aware of such proposals.

In the project abstract template, applicants are asked to indicate whether they give OJP permission to share their project abstract (including contact information) with the public if OJJDP does not fund the proposed project. Granting (or failing to grant) this permission will not affect OJP's funding decisions, and, if the application is not funded, granting permission will not guarantee that project abstract information will be shared, nor will it guarantee funding from any other source.

Note: OJP may choose not to list a project that otherwise would have been included in a listing of promising but unfunded applications, should the abstract fail to meet the format and content requirements noted above and outlined in the project abstract template.

3. Program Narrative

Applicants must submit a program narrative that presents a detailed description of the purpose, goals, objectives, strategies, design, and management of the proposed program. The program narrative should be double-spaced with 1-inch margins, not exceeding 30 pages of 8½ by 11 inches, and use a standard 12-point font, preferably Times New Roman. Pages should be numbered "1 of 30," etc. The tables, charts, pictures, etc., including all captions, legends, keys, subtext, etc., may be single-spaced and will count in the 30-page limit. Material required under the Budget and Budget Narrative and Additional Attachments sections will not count toward the program narrative page count. Applicants may provide bibliographical references as a separate attachment that will not count toward the 30-page program narrative limit. If the program narrative fails to comply with these length-related restrictions, OJJDP may consider such noncompliance in peer review and in final award decisions.

The program narrative should address the following selection criteria: (1) statement of the problem and project objectives, (2) program design and implementation, (3) potential impact, and (4) capabilities/competencies. The applicant should clearly delineate the connections between and among each of these sections. For example, the project design section should clearly explain how the program's structure and activities will respond to the problem statement identified in the previous section.

Guidelines for this program narrative include the following:

- **a. Title page** (not counted against the 30-page program narrative limit). Should include the title of the project, submission date, funding opportunity number, and the name and complete contact information (address, telephone number, and e-mail address) for both the applicant organization and the principal investigator or project director.
- **b. Table of contents and figures** (not counted against the 30-page program narrative limit).
- **c. Program narrative main body.** Should describe the proposed project in depth. The following sections should be included as part of the program narrative:
 - 1. Statement of the problem and project objectives. Applicants should briefly describe the nature and scope of the problem that the program will address (i.e., needs and gaps in juvenile reentry measurement). The applicant should use data to provide evidence of the need, demonstrate the size and scope of the need, and document the effects of the need on the target population and the larger community.

Applicants should describe any research or evaluation studies that relate to the need and contribute to the applicant's understanding of its causes and potential solutions. Applicants should address whether and how similar efforts have been addressed at the national, state, or local levels.

Applicants should discuss the need for juvenile reentry measurement standards and how their proposed project will address that need.

Applicants should address the key objectives/activities identified Under Goals, Objectives, and Deliverables on pages 5-8.

While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

- **2. Project design and implementation.** Applicants should provide a detailed description of the plan to address each of the key activities noted on pages 5-8. This includes detailed explanations of:
 - strategies to implement each of the key activities.
 - methods to incorporate a research-driven and practice-informed approach into each of the activities.
 - anticipated barriers to implementing each of the activities.
 - proposed methodology to pilot test the measurement standards including:
 - the potential sampling and site selection plan.
 - o the human subjects considerations.
 - how the applicant will examine implementation and use of the measurement standards, including measures of implementation or success.
 - o the data collection methods and statistical analyses anticipated.
 - potential delivery or platform formats and implementation considerations for the final measurement standards.

Timeline. Applicants should submit a realistic timeline or milestone chart that indicates major tasks associated with the goals and objectives of the project, assigns responsibility for each, and plots completion of each task by month or quarter for the duration of the award, using "Year 1," "Month 1," "Quarter 1," etc., not calendar dates (see "Sample Project Timelines").

Applicants should submit the timeline as a separate attachment, as stipulated in Appendices on page 16.

3. Potential impact. Applicants should describe the potential impact of the research and how it may inform or improve juvenile justice reentry policy, practice, and theory in the United States. This includes a description of:

- how the proposed project will inform juvenile justice systems reform and improvement efforts.
- implications for public safety and juvenile justice policy and practice.
- how applicants will address the deliverables stated in the Goals, Objectives, and Deliverables section on page 7.
- 4. Capabilities/competencies. This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar scope, design, and magnitude. Applicants should address:
 - experience and capacity to systematically synthesize and analyze research for projects of similar scope and size.
 - experience and capacity to develop a measurement system for projects of similar scope and size.
 - experience and capacity to pilot test new initiatives of similar scope and size.

OJJDP encourages applicants to subaward with organizations or individuals that have complementary skills and experiences for completing a project of this scope and size. Alternately, applicants may convene a body of consultants with diverse knowledge and experience with reentry research and practice to provide expertise and feedback.

Applicants should also highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability.

Management and staffing patterns should be clearly connected to the project design described in the previous section.

Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

d. Performance measures. To assist the Department with fulfilling its responsibilities under the Government Performance and Results Act of 1993 (GPRA), Public Law 103-62, and the GPRA Modernization Act of 2010, Public Law 111–352, applicants that receive funding under this solicitation must provide data that measure the results of their work done under this solicitation. OJP will require any award recipient, post award, to provide the data requested in the "Data Grantee Provides" column so that OJP can calculate values for the "Performance Measures" column. (Submission of performance measures data is not required for the application.) Performance measures for this solicitation are as follows:

OJJDP encourages award recipients to use information from existing program records to fulfill performance measures reporting requirements rather than initiating new data collection activities for this purpose.

- e. **Appendices.** Appendices (not counted against the 30 -page program narrative limit) include:
 - bibliography/references.
 - any tools/instruments, questionnaires, tables/charts/graphs, or maps pertaining to the proposed project that are supplemental to such items included in the main body of the narrative.
 - required: Curriculum vitae or resumes of the principal investigator or project director and all coprincipal investigators. In addition, curriculum vitae, resumes, or biographical sketches of all other individuals (regardless of investigator status) who will be significantly involved in substantive aspects of the proposal (including, for example, individuals, such as statisticians, serving as consultants to conduct proposed data analysis).
 - list (to the extent known) of all proposed project staff members, including those affiliated with the applicant organization or any proposed subrecipient organization(s), any proposed consultant(s) and contractors (whether individuals or organizations), and any proposed members of an advisory board for the project (if applicable). The list should include for each individual and organization: name, title (if applicable), employer or other organizational affiliation, and roles and responsibilities proposed for the project. Applicants should use the "Proposed Project Staff, Affiliation, and Roles" form to provide this listing.
 - proposed project timeline and expected milestones.
 - list of any previous and current OJJDP awards to applicant organization and investigator(s), including the OJJDP-assigned award numbers and a brief description of any scholarly products that resulted in whole or in part from work funded under the OJJDP award(s). (See "Goals, Objectives, Deliverables, and Expected Scholarly Products" under "Program-Specific Information," above, for definition of scholarly products.)
 - letters of cooperation/support or administrative agreements from organizations collaborating in the project (if applicable).
 - list of other agencies, organizations, or funding sources to which this proposal has been submitted (if applicable).

- letters of support/memoranda of understanding. If submitting an application with a subaward, as described under Eligibility, page 1, applicants should provide signed and dated letters of support or memoranda of understanding for all key partners that include the following:
 - expression of support for the program and a statement of willingness to participate and collaborate with it.
 - description of the partner's current role and responsibilities in the planning process and expected responsibilities when the program is operational.
 - estimate of the percent of time that the partner will devote to the planning and operation of the project.

4. Budget Detail Worksheet and Budget Narrative

a. Budget Detail Worksheet. A sample Budget Detail Worksheet can be found at www.ojp.gov/funding/Apply/Resources/BudgetDetailWorksheet.pdf. Applicants that submit their budget in a different format should include the budget categories listed in the sample budget worksheet. (Work associated with satisfying data archiving requirements should be reflected.) OJJDP expects applicants to provide a thorough narrative to each section of the Budget Detail Worksheet.

For questions pertaining to budget and examples of allowable and unallowable costs, see the Financial Guide at www.ojp.gov/financialguide/index.htm.

b. Budget Narrative. The budget narrative should thoroughly and clearly describe every category of expense listed in the Budget Detail Worksheet. OJP expects proposed budgets to be complete, cost effective, and allowable (e.g., reasonable, allocable, and necessary for project activities).

Applicants should demonstrate in their budget narratives how they will maximize cost effectiveness of grant expenditures. Budget narratives should generally describe cost effectiveness in relation to potential alternatives and the goals of the project. For example, a budget narrative should detail why planned in-person meetings are necessary, or how technology and collaboration with outside organizations could be used to reduce costs, without compromising quality.

The narrative should be sound mathematically, and correspond with the information and figures provided in the Budget Detail Worksheet. The narrative should explain how the applicant estimated and calculated <u>all</u> costs, and how they are relevant to the completion of the proposed project. The narrative may include tables for clarification purposes but need not be in a spreadsheet format. As with the Budget Detail Worksheet, the Budget Narrative should be broken down by year.

c. Noncompetitive procurement contracts in excess of simplified acquisition threshold. If an applicant proposes to make one or more noncompetitive procurements of products or services, where the noncompetitive procurement will exceed the simplified acquisition threshold (also known as the small purchase threshold), which is currently set at \$150,000, the application should address the considerations outlined in the <u>Financial Guide</u>.

d. Preagreement cost approvals. For information on preagreement costs approvals, see Section B. Federal Award Information.

5. Indirect Cost Rate Agreement (if applicable)

Indirect costs are allowed only if the applicant has a current federally approved indirect cost rate. (This requirement does not apply to units of local government.) Attach a copy of the federally approved indirect cost rate agreement to the application. Applicants that do not have an approved rate may request one through their cognizant federal agency, which will review all documentation and approve a rate for the applicant organization, or, if the applicant's accounting system permits, costs may be allocated in the direct cost categories. For the definition of Cognizant Federal Agency, see the "Glossary of Terms" in the <u>Financial Guide</u>. For assistance with identifying your cognizant agency, please contact the Customer Service Center at 1-800-458-0786 or at ask.ocfo@usdoj.gov. If DOJ is the cognizant federal agency, applicants may obtain information needed to submit an indirect cost rate proposal at www.oip.gov/funding/Apply/Resources/IndirectCosts.pdf.

6. Tribal Authorizing Resolution (if applicable)

Tribes, tribal organizations, or third parties proposing to provide direct services or assistance to residents on tribal lands should include in their applications a resolution, a letter, affidavit, or other documentation, as appropriate, that certifies that the applicant has the legal authority from the tribe(s) to implement the proposed project on tribal lands. In those instances when an organization or consortium of tribes applies for a grant on behalf of a tribe or multiple specific tribes, the application should include appropriate legal documentation, as described above, from all tribes that would receive services or assistance under the grant. A consortium of tribes for which existing consortium bylaws allow action without support from all tribes in the consortium (i.e., without an authorizing resolution or comparable legal documentation from each tribal governing body) may submit, instead, a copy of its consortium bylaws with the application.

Applicants unable to submit an application that includes a fully executed (i.e., signed) copy of appropriate legal documentation, as described above, consistent with the applicable tribe's governance structure, should submit, at a minimum, an unsigned, draft version of such legal documentation as part of its application (except for cases in which, with respect to a tribal consortium applicant, consortium bylaws allow action without the support of all consortium member tribes). If selected for funding, OJJDP will make use of and access to funds contingent on receipt of the fully executed legal documentation.

7. Applicant Disclosure of High Risk Status

Applicants are to disclose whether they are currently designated high risk by another federal grant making agency. This includes any status requiring additional oversight by the federal agency due to past programmatic or financial concerns. If an applicant is designated high risk by another federal grant making agency, you must email the following information to OJPComplianceReporting@usdoj.gov at the time of application submission:

• The federal agency that currently designated the applicant as high risk

- Date the applicant was designated high risk
- The high risk point of contact name, phone number, and email address, from that federal agency
- Reasons for the high risk status

OJP seeks this information to ensure appropriate federal oversight of any grant award. Unlike the Excluded Parties List, this high risk information does not disqualify any organization from receiving an OJP award. However, additional grant oversight may be included, if necessary, in award documentation.

8. Additional Attachments

a. Applicant disclosure of pending applications⁵. Applicants are to disclose whether they have pending applications for federally funded grants or subgrants (including cooperative agreements) that include requests for funding to support the same project being proposed under this solicitation and will cover the identical cost items outlined in the budget narrative and worksheet in the application under this solicitation. The disclosure should include both direct applications for federal funding (e.g., applications to federal agencies) and indirect applications for such funding (e.g., applications to state agencies that will subaward federal funds).

OJP seeks this information to help avoid any inappropriate duplication of funding. Leveraging multiple funding sources in a complementary manner to implement comprehensive programs or projects is encouraged and is not seen as inappropriate duplication.

Applicants that have pending applications as described above are to provide the following information about pending applications submitted within the last 12 months:

- The federal or state funding agency
- The solicitation name/project name
- The point of contact information at the applicable funding agency

Applicants should include the table as a separate attachment, with the file name "Disclosure of Pending Applications," to their application. Applicants that do not have pending applications as described above are to include a statement to this effect in the separate attachment page (e.g., "[Applicant Name on SF-424] does not have pending applications submitted within the last 12 months for federally funded grants

or subgrants (including cooperative agreements) that include requests for funding to support the same project being proposed under this solicitation and will cover the identical cost items outlined in the budget narrative and worksheet in the application under this solicitation.").

- b. Research and evaluation independence and integrity. If a proposal involves research and/or evaluation, regardless of the proposal's other merits, in order to receive funds, the applicant must demonstrate research/evaluation independence, including appropriate safeguards to ensure research/evaluation objectivity and integrity, both in this proposal and as it may relate to the applicant's other current or prior related projects. This documentation may be included as an attachment to the application which addresses BOTH i. and ii. below.
 - i. For purposes of this solicitation, applicants must document research and evaluation independence and integrity by including, at a minimum, one of the following two items:
 - a. A specific assurance that the applicant has reviewed its proposal to identify any research integrity issues (including all principal investigators and subrecipients) and it has concluded that the design, conduct, or reporting of research and evaluation funded by OJJDP grants, cooperative agreements, or contracts will not be biased by any personal or financial conflict of interest on the part of part of its staff, consultants, and/or sub-recipients responsible for the research and evaluation or on the part of the applicant organization;

OR

- b. A specific listing of actual or perceived conflicts of interest that the applicant has identified in relation to this proposal. These conflicts could be either personal (related to specific staff, consultants, and/or sub-recipients) or organizational (related to the applicant or any subgrantee organization). Documentation that may be helpful in this regard could include organizational codes of ethics/conduct or policies regarding organizational, personal, and financial conflicts of interest. There is no guarantee that the plan, if any, will be accepted as proposed.

Considerations in assessing research and evaluation independence and integrity will include, but are not be limited to, the adequacy of the applicant's efforts to identify factors that could affect the objectivity or integrity of the proposed staff and/or the organization in carrying out the research, development, or evaluation activity; and the adequacy of the applicant's existing or proposed remedies to control any such factors.

9. Financial Management and System of Internal Controls Questionnaire

In accordance with <u>2 CFR 200.205</u>, federal agencies must have in place a framework for evaluating the risks posed by applicants before they receive a federal award. To facilitate part of this risk evaluation, **all** applicants (other than an individual) are to download, complete, and submit this <u>form</u>.

Applicants must register in, and submit applications through Grants.gov, a "one-stop storefront" to find federal funding opportunities and apply for funding. Find complete instructions on how to register and submit an application at www.Grants.gov. Applicants that experience technical difficulties during this process should call the Grants.gov Customer Support Hotline at 800-518-4726 or 606–545–5035, 24 hours a day, 7 days a week, except federal holidays. Registering with Grants.gov is a one-time process; however, processing delays may occur, and it can take several weeks for first-time registrants to receive confirmation and a user password. OJP encourages applicants to register several weeks before the application submission deadline. In addition, OJP urges applicants to submit applications 72 hours prior to the application due date to allow time to receive validation messages or rejection notifications from Grants.gov, and to correct in a timely fashion any problems that may have caused a rejection notification.

OJJDP strongly encourages all prospective applicants to sign up for Grants.gov email notifications regarding this solicitation. If this solicitation is cancelled or modified, individuals who sign up with Grants.gov for updates will be automatically notified.

Note on file names and file types. Grants.gov <u>only</u> permits the use of <u>certain specific</u> characters in names of attachment files. GMS does not accept executable file types as application attachments. These disallowed file types include, but are not limited to, the following extensions: ".com," ".bat," ".exe," ".vbs," ".cfg," ".dat," ".db," ".dbf," ".dll," ".ini," ".log," ".ora," ".sys," and ".zip." GMS may reject applications with files that use these extensions. It is important to allow time to change the type of file(s) if the application is rejected.

All applicants are required to complete the following steps:

OJP may not make a federal award to an applicant until the applicant has complied with all applicable DUNS and SAM requirements. If an applicant has not fully complied with the requirements by the time the federal awarding agency is ready to make a federal award, the federal awarding agency may determine that the applicant is not qualified to receive a federal award and use that determination as a basis for making a federal award to another applicant.

- 1. Acquire a Data Universal Numbering System (DUNS) number. In general, the Office of Management and Budget requires that all applicants (other than individuals) for federal funds include a DUNS number in their applications for a new award or a supplement to an existing award. A DUNS number is a unique nine-digit sequence recognized as the universal standard for identifying and differentiating entities receiving federal funds. It is possible to first receive a message indicating that the application is received and then receive a rejection notice a few minutes or hours later. Experiencing Unforeseen Grants.gov Technical Issues

Applicants that experience unforeseen Grants.gov technical issues beyond their control that prevent them from submitting their application by the deadline must contact the Grants.gov Customer Support Hotline or the SAM Help Desk to report the technical issue and receive a tracking number. The applicant must e-mail the Response Center at responsecenter@ncjrs.gov within 24 hours after the application deadline and request approval to submit their application. - 1. Demonstrated understanding of the problem and objectives of the initiative.
- 2. Demonstrated awareness of the state of current research.

Project Design and Implementation (Quality and technical merit) – 45 percent

- 1. Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- 2. Feasibility of proposed project.
- 3. Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- 4. Likelihood of proposed approach to address the key activities outlined under Goals, Objectives, and Deliverables.

Potential Impact – 15 percent

Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States, such as—

- 1. Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- 2. Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- 3. Potential for solution to be scalable and replicable nationally.
- 4. Plan and ability to disseminate to broader audiences (e.g., policymakers and the public).

Capabilities/Competencies (Capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) – 25 percent

- Qualifications and experience of proposed project staff (the principal investigator or project director, all coprincipal investigators, and all other individuals (and organizations) identified in the application (regardless of investigator status) who will be significantly involved in substantive aspects of the proposal).
- 2. Demonstrated ability of the applicant organization to manage the effort.
- 3. Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope of the proposed project.
- 4. Relationship of the proposed project staff (including the applicant organization) to key stakeholders and agencies that may implement the measurement standards.

Budget

Peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- 1. Total cost of the project relative to the perceived benefit (cost effectiveness).
- 2. Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.
- 4. Proposed budget alignment with proposed project activities.

Review Process

OJP is committed to ensuring a fair and open process for awarding grants. OJJDP reviews the application to make sure that the information presented is reasonable, understandable, measurable, and achievable, as well as consistent with the solicitation.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether applicants have met basic minimum requirements, OJP screens applications for compliance with specified program requirements to help determine which applications should proceed to further consideration for award. Although program requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP grant programs:

- an eligible type of applicant must submit the application.
- applications must request funding within programmatic funding constraints, if applicable.
- applications must be responsive to the scope of the solicitation.
- applications must include all items designated as critical elements.
- applicants will be checked against the General Services Administration's Excluded Parties List.

For a list of critical elements, see "What an Application Should Include" under <u>Section D.</u> <u>Application and Submission Information.</u>

OJJDP may use internal peer reviewers, external peer reviewers, or a combination, to assess applications meeting basic minimum requirements on technical merit using the solicitation's selection criteria. An external peer reviewer is an expert in the subject matter of a given solicitation who is not a current DOJ employee. An internal reviewer is a current DOJ employee who is well-versed or has expertise in the subject matter of this solicitation. A peer review panel will evaluate, score, and rate applications that meet basic minimum requirements.

OJP reviews applications for potential discretionary awards to evaluate the risks posed by applicants before they receive an award. This review may include but is not limited to the following:

- 1. Financial stability and fiscal integrity.
- 2. Quality of management systems and ability to meet the management standards prescribed in the Financial Guide.
- 3. History of performance.
- 4. Reports and findings from audits.
- 5. The applicant's ability to effectively implement statutory, regulatory, or other requirements imposed on nonfederal entities.
- 6. Proposed costs to determine if the Budget Detail Worksheet and Budget Narrative accurately explain project costs, and whether those costs are reasonable, necessary, and allowable under applicable federal cost principles and agency regulations.

The OJJDP Administrator will make all final award decisions. Peer reviewers' ratings and any resulting recommendations are advisory only, although their views are considered carefully. In addition to peer review ratings, considerations for award recommendations and decisions may include, but are not limited to, planned products, proposed budgets, past performance (including similar products) under prior OJJDP and OJP awards, strategic priorities, and available funding when making awards.

F. Federal Award Administration Information

Federal Award Notices

OJP award notification will be sent from GMS. Recipients will be required to login; accept any outstanding assurances and certifications on the award; designate a financial point of contact; and review, sign, and accept the award. The award acceptance process involves physical signature of the award document by the authorized representative and the scanning of the fully-executed award document to OJP.

Administrative, National Policy, and Other Legal Requirements

If selected for funding, in addition to implementing the funded project consistent with the agency-approved project proposal and budget, the recipient must comply with award terms and conditions, and other legal requirements, that are included in the award, incorporated into the award by reference, or are otherwise applicable to the award. OJP strongly encourages prospective applicants to review the information pertaining to these requirements **prior** to submitting an application. To assist applicants and recipients in accessing and reviewing this information, OJP has placed it on its <u>Solicitation Requirements</u> page of the OJP Funding Resource Center.

Standard Assurances

Upon grant approval, OJP electronically transmits (via GMS) the award document to the prospective award recipient. In addition to other award information, the award document contains award terms and conditions that specify national policy requirements⁶ with which recipients of federal funding must comply; uniform administrative requirements, cost principles, and audit requirements; and program-specific terms and conditions required based on applicable program (statutory) authority or requirements set forth in OJP solicitations and program announcements. For example, certain efforts may call for special requirements, terms, or conditions relating to intellectual property, data/information-sharing or -access, or information security; or audit requirements, expenditures and milestones, or publications and/or press releases.

OJP also may place additional terms and conditions on an award based on its risk assessment of the applicant, or for other reasons it determines necessary to fulfill the goals and objectives of the program.

Prospective applicants may access and review the text of mandatory conditions OJP includes in all OJP awards, as well as the text of certain other conditions, such as administrative conditions, via OJP's <u>Mandatory Award Terms and Conditions</u> page of the Funding Resource Center.

As stated above, OJJDP expects that it will make any award from this solicitation in the form of a cooperative agreement. Cooperative agreement awards include standard "federal involvement" conditions that describe the general allocation of responsibility for execution of the funded program. Generally-stated, under cooperative agreement awards, responsibility for the day-to-day conduct of the funded project rests with the recipient in implementing the funded and approved proposal and budget, and the award terms and conditions. Responsibility for oversight and redirection of the project, if necessary, rests with OJJDP. OJJDP's role will include the following tasks:

- reviewing and approving major work plans, including changes to such plans, and key decisions pertaining to project operations.
- reviewing and approving major project-generated documents and materials used in the provision of project services.
- providing guidance in significant project planning meetings and participating in project sponsored training events or conferences.

See generally 2 C.F.R. 200.300 (provides a general description of national policy requirements typically applicable to recipients of Federal awards, including the Federal Funding Accountability and Transparency Act of 2006 (FFATA)).

In addition to any "federal involvement" condition(s), OJP cooperative agreement awards include a special condition specifying certain reporting requirements required in connection with conferences, meetings, retreats, seminars, symposium, training activities, or similar events funded under the award, consistent with OJP policy and guidance on "conference" approval, planning, and reporting.

Human Subjects and Privacy Certificate

DOJ regulations (28 C.F.R. Part 46) protect the human subjects of federally funded research. Part 46 requires that an Institutional Review Board, in accordance with the regulations, review and approve most research involving human subjects that any federal department or agency conducts or supports before an award recipient may expend federal funds for that research. As a rule, persons who participate in federally funded research must provide their informed consent and must be permitted to terminate their participation at any time. Funding recipients, before they will be allowed to spend OJP funds on any research activity involving human subjects, must submit appropriate documentation to OJP showing compliance with 28 C.F.R. Part 46 requirements, as requested by OJP.

DOJ regulations (28 C.F.R. Part 22) require recipients of OJP funding to submit a Privacy Certificate as a condition of approval of any grant application or contract proposal that contains a research or statistical component under which "information identifiable to a private person" will be collected, analyzed, used, or disclosed. The funding recipient's Privacy Certificate includes a description of its policies and procedures to be followed to protect the confidentiality of identifiable data (28 C.F.R. § 22.23). The Department's regulations provide, among other matters, that: "Research or statistical information identifiable to a private person may be used only for research or statistical purposes (28 C.F.R. § 22.21)." Moreover, any private person from whom information identifiable to a private person is collected or obtained (either orally or by means of written questionnaire or other document) must be advised that the information will only be used or disclosed for research or statistical purposes and that compliance with the request for information is voluntary and may be terminated at any time (28 C.F.R. § 22.27).

Applicants selected for an award will be required to submit all appropriate IRB and privacy documents prior to spending OJP funds for research-related activities.

General Information About Post-Federal Award Reporting Requirements

Recipients must submit quarterly financial reports and semi – annual progress reports, final financial and progress reports, and, if applicable, an annual audit report in accordance with 2 CFR Part 200. Applicants should anticipate that progress reports will be required to follow the non-budgetary components of the Research Performance Progress Report (RPPR) template/format. General information on RPPRs may be found at www.nsf.gov/bfa/dias/policy/rppr/. Future awards and fund drawdowns may be withheld if reports are delinquent.

Special Reporting requirements may be required by OJP depending on the statutory, legislative or administrative requirements of the recipient or the program.
